The eligibility criteria for the prospective applicants for the post of "**Professor Emeritus**" shall be as under:

- 1. He/she must be a retired Professor from Centrally Funded Institutions like IITs / NITs / IIITs, Centrally Funded Institutions within NIRF Ranking of 100.
- 2. He/she should have been actively engaged in teaching and research in the tenure of his/her position as a Professor and guided significant number of PhD Students and published research articles in journal of web of sciences.
- 3. He/she must possess qualification with international visibility, high-quality of research publications in journals and conferences, fellowship of Academy or Professional Society.
- 4. He/she must have executed significant high value sponsored research and consultancy projects in the area of Computer Science / Electronics Engineering.
- 5. He/she must have supervised M. Tech./ M.Phil. and Ph. D. students.
- 6. He/she should have associated himself/herself as volunteer and program committee member in national/international conference, editor/editorial committee in reputed journal, and should have dealt patent and consultancy.

7. He/she should have publications of high academic standards with h-index (web of science) 10 or

more.

The eligibility criteria for the prospective applicants for the post of "Professor of Practice" shall be

as under:

1. He/she will be a reputed Scientists from Central Government Research Institutions or distinguished

Industry Professional in the Information Technology & Allied Fields with work experience at the level

of Director, Managing Director, Chief Technology Officer, Chief Executive Officer etc.

2. He should have worked in the reputed industry at the above levels for minimum five years. The reputed

industry means the industry having 1000 or more employees with minimum turnover of Rs. 10,000

Crores.

Accordingly, apart from teaching fundamental core and elective subjects, Indian Institute of Information Technology, Nagpur expects active contribution of the Professor Emeritus / Professor of Practice towards:

The terms of appointment for the post of Professor Emeritus / Professor of Practice shall be as under:

1. The appointment shall be purely on contract basis.

- 2. The appointment shall be subject to general terms and conditions of service applicable to the employees of IIIT-Nagpur as in force under IIIT (Public-Private Partnership) Act, 2017, Institute Statutes as amended from time to time and other applicable rules/policies of the Institute.
- 3. The post will carry a consolidated honorarium of ₹ 1,20,000/- per month.
- 4. In addition to the above consolidated honorarium, the Professor Emeritus / Professor of Practice shall be entitled for expenses like travel, accommodation (if available), conference registration fees etc on case-to-case basis subject to prior approval of the Director of the Institute.
- 5. He/she will be provided facilities equivalent to Professor in the Department to which he/she is attached.
- 6. He/she will not have any administrative responsibility.
- 7. He/she will be required to undertake normal academic load.
- 8. He/she will be expected to participate in sponsored research and consultancy activities as coinvestigator in association with regular faculty members of the Institute. He/she will need to share lab space with a faculty.
- 9. He/she would be eligible to guide the PhD Scholars as co-investigator admitted by the Institute. However, he/she will not be a sole PI or Supervisor of any student.
- 10. His/her performance shall be subject to review by the Director of the Institute.
- 11. He/she will be entitled for Casual Leaves as applicable to contract employees.

The Director shall have the right to add / delete the terms of appointment in the interest of the Institute and in line with the above terms while issuing the appointment offer to the selected candidate.
